PeopleSoft Academic Advisement Documentation Updates for SA Bundle #19

Note. This document is an update to the *PeopleSoft 8 SP1 Academic Advisement PeopleBook*. It describes the Product Update ID #656271 that was posted to Customer Connection in June 2007. Use this document in conjunction with your PeopleBooks to maintain a complete set of documentation.

This document discusses changes related to updates and fixes delivered with SA Bundle #19. Specifically, it discusses changes to the way that the advisement engine manages local limits and credit splitting.

Local Limits and Credit Splitting

The functionality behind the **Enable Splitting** check box on the Line Item Parameters page is enhanced to work correctly based on the following rules:

- If a user selects the **Enable Splitting** check box on a requirement line that is a local limit, the audit engine performs splitting only for requirement lines for which the **Enable Splitting** check box is selected.
- If a user selects the **Enable Splitting** check box on a requirement line that is a local limit and the requirement line points to derived lists where the **List Recall Mode** value is **Used by Requirement** or **Used by Requirement Group**, splitting occurs only if the **Enable Splitting** check box is selected for those requirement lines targeted by the derived lists.
